

Quarterly fund commentary

Asia Pacific ex-Japan equity markets declined 0.9% (total return) in the second quarter, while Asian bonds (denominated in US dollars) fell 0.7% (total return), in US\$ terms. The Greater China equity markets were up, while the rest of the region ended the quarter in negative territory. The Chinese offshore and Hong Kong equity markets were boosted by the announcement that domestic mutual funds could invest in Chinese stocks listed on the Hong Kong exchange using the Shanghai-Hong Kong Stock Connect. Within the equity portion, we added to the Chinese and Hong Kong banks that we believe have solid fundamentals and high dividend yields. In Taiwan, we reduced exposure to some information technology hardware companies, which are facing deterioration in their competitive positioning in their industry. Within bonds, we continued to favour corporate bonds over sovereign bonds. China remained our preferred bond exposure, as corporate bonds continued to be supported by an accommodative monetary environment.


