Created on 15 December 2008, Dorval Global Convictions, is a flexible and diversified fund. Its equity component may vary between 0% and 100%. The benchmark index is composed of 50% Eonia and 50% MSCI global index of international equities, the MSCI World NR (EUR), calculated with net total return since 1 January 2013. The investment strategy is a Three-step process : 1) The global macroeconomic environment is analysed in order to appropriately determine the asset allocation with respect to asset class, geographical choices as well as the identification of the main investment themes 2) creation of thematic and/or geographical baskets of shares or/and bonds on the basis of a quantitative filtering of the investment universe by liquidity criteria, financial analysis and valuation in order to apply fund managers' analysis 3)An active management of risk hedging


MONTHLY COMMENTARY

Political events dominated the headlines in August, with fresh tensions in emerging countries in the wake of the trade war. After strife in Argentina, this time it was Turkey's turn to take a nosedive, sparking investor fears of a potential domino effect for emerging countries on a par with the situation in 1998 during the Asian crisis. Rate hikes in the US, escalating trade tensions and the surge in the dollar combined to shine the spotlight on vulnerabilities in certain countries, but conversely the situation in Asia is very different, with most countries having little or no current account deficit and boasting substantial currency reserves. The real crux of the matter is the relationship between the US and China – how it will develop and any potential ensuing collateral damage – but we are unlikely to see a swift outcome as the next summit meeting is only slated for after the US midterm elections in November. Looking to the euro area, discussions on the Italian budget are also a drag on confidence. However, looking beyond this factor, it is worth mentioning the improvement in economic momentum as well as a more flattering base of comparison for materials and the impact from currencies to be expected in the second half of the year. Lastly, economic activity in the US is being shored up by the tax package, while 2Q corporate earnings show an increase of more than 20%.

The valuation gap between the US and the rest of the world logically widened further, drawing close to levels seen in 2008.


Our strategy has been to seek to take advantage of high risk premiums in emerging economies and Southern Europe over recent months, but this has knocked our performance, and so we have made tactical moves to either cut back or hedge these positions pending the outcome of these various situations.

Definitions	
Alpha:	A fund's outperformance compared with its benchmark, expressed as a percentage. This is an indicator of the manager's ability to create value, by excluding the market effect. Therefore, the higher the alpha, the better the fund's performance compared with that of its benchmark.
Beta:	Measure of a fund's sensitivity to market movements (represented by its benchmark). A beta higher than 1 indicates that the fund amplifies the trends of its reference market on the upside as well as on the downside. Conversely, a beta lower than 1 means that the fund tends to react less to movements in its reference market.
Sharpe ratio:	Indicator of a product's outperformance relative to a risk-free interest rate, given the risk taken (the product's volatility). The higher it is, the better the fund.
Volatility:	Magnitude of the variation of a security, a fund, a market or of an index over a given period. A high volatility means that the price of the security varies significantly, and therefore that the security's associated risk is high.
Maximum performance:	Maximum gain historically recorded by the fund.
Maximum drawdown:	Maximum loss historically recorded by the fund.
Recovery period:	Time expressed in number of days the fund takes to exceed the highest net asset value over the indicated period.
Gain frequency:	Calculation over the fund's history since its creation representing the ratio of the number of positive observations to the total number of observation in the period.
Exposure as a percentage:	The fund's overall exposure takes into account the sum of the physical and off-balance sheet positions. As opposed to positions called of net assets: "physical"(those booked in the portfolio's inventory of assets), off-balance sheet positions include those taken in forward financial instruments, such as derivatives.
