

Quarterly fund commentary

Cumulative performance*

Credit markets showed strong performance in the third quarter, continuing the rally that began in mid-February. Growing global growth and supportive central bank policy have continued to provide a positive backdrop for credit. Decent employment and inflation numbers in the US set the proper stage for a US Federal Reserve interest rate hike, although we don't estimate any moves until the December meeting. In September, portfolio managers paired back risk exposure to lower quality investment grade credit, emerging market debt and, particularly, high yield which has demonstrated very strong performance since early in the year. Managers have reduced overall risk exposure given valuations and potential catalysts for increased volatility. Fundamentals remain supportive but risks lie in potentially slower global growth, tightening financial conditions, high levels of debt in the emerging world – particularly China – and upcoming political events across the US and Europe. Across credit markets, managers continue to focus on solid issuer fundamentals and maintain flexibility to adjust exposures to opportunities should increased volatility materialise.


