Quarterly fund commentary

Bond yields across most markets increased in the second calendar guarter of 2015 as both government yields increased and credit spreads widened. Lower quality bonds outperformed higher quality across most developed and emerging markets although credit markets sold off toward the end of the quarter reflecting sensitivity to events in Greece as well as growth concerns in China. During the guarter, the fund reduced exposure to investment grade debt while increasing exposure to collateralized loan obligations (CLO's). The fund's investments in high yield bonds and bank loans, through CLO's, proved to be the best performing asset classes. The fund reduced US duration (a measure of a bond's sensitivity to interest rate changes) exposure and hedged against Greece-induced volatility through a derivative overlay. Toward the end of the guarter, we also added exposure to Irish and Portuguese debt which had weakened in response to Greece. The fund also had selective opportunistic investments in US municipal bonds. Looking ahead, we expect modest growth in developed markets, challenges in emerging markets and volatility to remain elevated. As such, we believe tactical asset allocation and good security selection will be critical for navigating markets for the balance of the year.
