

Quarterly fund commentary

Asia Pacific ex-Japan equities ended Q3 lower, while Asian dollar bonds fell marginally. Equity market weakness was largely due to fears about the slowdown in China's economy and the devaluation of the Chinese yuan, as well as concerns the US Federal Reserve would raise interest rates in September, which it did not. Greater China equity markets all fell, with the Taiwan central bank cutting interest rates for the first time in four years to help fend off disinflationary pressures and support economic growth. Commodity exporters such as Malaysia and Australia were hit particularly hard by continued exports growth weakness. Asian bonds registered mildly negative returns. We continued to target a 60/40 allocation between equities/bonds due to the relative attractiveness of equity dividend yields. Asian equity markets have been volatile, but we believe valuations have become compelling. We continue to favour companies with what we consider to be sustainable cash-flows and dividends. In bonds, we continue to rafour corporate bonds over sovereign bonds, preferring to take exposure in China where corporate credit continues to be supported by accommodative monetary policy. The currency exposure of the bond portion remains US dollar based, with hedged non-USD dollar exposure in Australia and Taiwanese equities.


