

### Quarterly fund commentary

Asia Pacific ex Japan equity market and bonds fell in the last guarter of 2016 with Asian bonds being more resilient. Rising uncertainty surrounding policy in the US, especially trade policy, influenced investor flows into the region. Within equities, Greater China equity markets fell in Q4, as Chinese government's efforts to cool down the property market and rising interest rates elsewhere weighed on markets and sentiment. Despite the pullback in equity markets, economic activity remained relatively solid in China. During the quarter, commodity prices continued to strengthen, which was positive for Australia. As for equity sector performance, the energy and materials sectors continued to lead gains, while the telecommunication services, utilities and healthcare sectors underperformed. We maintained our tilt in Asian high dividend equities with our positions in equities and bonds remaining relatively unchanged. Our largest equity exposures continued to be with Australia and China. In fixed income, the majority of bonds were in US dollar-denominated Chinese issued bonds. On our currency management, we maintained a strengthening bias in the USD and maintained a high exposure in US and HK dollars by implementing currency hedges on select Asian currencies.


