

Quarterly fund commentary

The China-US trade tensions have escalated to trade war. We are cautious on the Chinese sectors of exports, metals, telecom, media and technology. We will continue to maintain underweight in those sectors compared to the reference index. Our interest rate hedging strategy has been reducing interest rate risk to the fund when the US Federal Reserve ('Fed') continued to hike interest rates and the inflationary pressures intensified. We endeavor to keep the fund's duration (sensitivity to interest rate) below 0.5 years for most of the time, compared to the Reference Index's duration of over 6 years. We will continue to keep the fund fully exposed to the US dollar, avoiding Asian currencies. As the Asian currencies may not subject to big currency risk due to strong US dollar.




