

Quarterly fund commentary

The shadow of higher US interest rates in 2H 2O15 will, in our view, place many Asian currencies under pressure of depreciation. We are therefore underweight in Asian local currency bonds as compared to the HSBC Asian USD Bond TR benchmark. The exception is the Chinese Renminbi (RMB) bond market, where we continue to see value. The RMB is supported by a strong sovereign credit profile. We believe the disinflationary pressures in China will lead to lower interest rates over the next 12 months, underlined by stable RMB currency performance (down 0.2% only against the US dollar in 1H 2O15). We have an overweight position in the bonds of commodities importing countries too. In our view, weak global commodities prices are positive for commodities importers like China and India, while negative for commodities exporters like Indonesia and Malaysia. Overall, the Asian US\$ corporate bonds are tending to provide higher yields than their European and US counterparts of similar maturities and credit ratings. Given the low yield environment in developed markets and the geopolitical turmoil in some parts of ex-Asia emerging markets, we expect more global capital to flow into Asia to buy US\$ bonds and we will actively look for opportunities to add Asian US\$ bond exposures on perceived market weakness.


