Quarterly fund commentary

The USD Accumulation Share Class of the fund won the "Best-In-Class" Award from BENCHMARK in 2017. Our interest rate hedging strategy has been reducing interest rate risk to the fund when the US Federal Reserve ('Fed') continued to hike interest rates and the inflationary pressures intensified. We endeavor to keep the fund's duration (sensitivity to interest rate) below 0.5 years for most of the time, compared to the Reference Index's duration of over 6 years. We will continue to keep the fund fully exposed to the US dollar, avoiding Asian currencies. To avoid shocks from geopolitical tensions of the Korean Peninsula, we will continue to maintain zero exposure to Korea. As we feel Asian high yield bonds (rated below BBB/Baa) represent a good and improving credit risk (the risk of nonrepayment, which we feel is diminishing), and their default rates have stayed at low levels, the fund has been increasing Asian high yield bond exposure with the aim of increasing the fund's yield.


