
# **Invesco Asian Bond Fund** E-Acc Shares

### Quarterly fund commentary

Under our "all-weather" investment style, we timely switched to a risk-on mode in July to capture market rally and subsequently switched back to a "risk-off" mode towards the end of August in light of the risks of rising US dollar LIBORs, negative headline news of a German bank and uncertainties of US presidential elections. To control volatility risk to the Fund, we increased cash position and added positions of credit risk free US government debt securities. We target to buy Asian USD bonds on price weaknesses in the third quarter. To save bid-ask spread transaction costs, we will focus on the primary market for new issues. As we expect most Asian currencies to continue their weakening trends against the US dollar, we will avoid Asian local currency exposures. We have turned to be more cautious on the Chinese property sector due to tightening housing policies. However, we will continue to overweigh in China USD bonds. As their yields are higher than the domestic corporate bond yields, strong home-biased demand from Chinese investors should persist to support the China USD bond prices. We will look for opportunities to increase exposures to Indonesia and India in light of strong economic reform momentum of these two countries.
