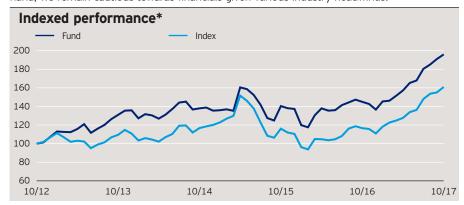

### Quarterly fund commentary

China's equity market continued to rally in Q3, benefiting from broad-based corporate earnings upgrades and ongoing inflows. Macroeconomic data remained robust, with positive manufacturing surveys and resilient growth in industrial profits and retail sales. In terms of sector performance, the IT sector led market gains on the back of the positive outlook for earnings. In terms of investment strategy, we have a bottom-up approach to stock selection with a focus on companies that enjoy what we consider to be sustainable leadership and competitive advantages. As such, we have a tilt towards consumer sectors, including the internet services industry, where we are able to find better stock opportunities. On the other hand, we remain cautious towards financials given various industry headwinds.

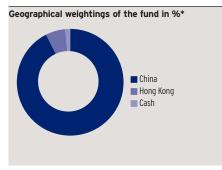

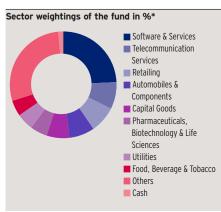
