Quarterly fund commentary

Chinese equities finished the fourth quarter lower. The domestic economy remained stable with real GDP growth rate set to achieve the central government's target of around 6.5%. Consumption and services growth continued to show resilience, supported by healthy household income growth. There were however signs of moderation in recent months. For example, the official manufacturing PMI, a gauge for measuring the health of the country's manufacturing sector, fell below its expansion threshold, suggesting a moderation in domestic demand and a dip in external sentiment. However, the government has taken some positive support measures including cuts in banks' reserve requirements, a lowering of some taxes, and an increase in infrastructure spending to stabilize near-term economic growth. Meanwhile, Sino-US trade relations took a step forward in the fourth guarter following high-level bilateral talks. In terms of sector performance, real estate led market gains on expectations of a possible relaxation of property tightening policies. The utilities sector also proved favourable on improved earnings and domestic growth catalysts. By way of investment strategy, our bottom-up approach to stock selection focuses on companies with sustainable leadership and competitive advantage. This has led to higher exposure towards consumer sectors where we have found better opportunities and believe the government will remain supportive of their growth.




