Quarterly fund commentary

Emerging market local currency bonds returned 0.82% for the guarter, as measured by the J.P. Morgan GBI-EM Global Diversified Index. The index yield ended the period at 6.14%. Returns in local currency terms were positive for the quarter while EMFX appreciated versus USD and EUR. Market technicals remain very strong and the rebound in commodity prices, on the back of ever easier global financial conditions, provides a solid backdrop for local market risks. Weak domestic demand and stronger currencies, support further monetary easing by many central banks. This is supportive of our long duration views. Strong global growth is negative for the US dollar as capital seeks riskier markets. Inflation risks in the US remain subdued, but we are closely monitoring wage growth, as a sign that the Federal Reserve may have to tighten monetary policy more than is currently priced. We have moderately increased our short US dollar position against higher carry currencies in the portfolio.




