

Quarterly fund commentary

With weakening commodity prices, increasing signs of vulnerability among emerging markets and deterioration in the high yield bond market, stock market volatility spiked during the guarter and the US Federal Reserve chose not to increase interest rates. While no sector was a safe haven, the energy sector was among the worst performers with double digit losses overall. The fund underperformed its benchmark, the MSCI World Energy Index. Key relative detractors included security selection and overweight exposure in oil & gas exploration & production and oil & gas drilling, as well as an underweight exposure in integrated oil & gas. A lack of exposure in oil & gas refining & marketing and coal contributed positively to relative performance. Additionally, a minor allocation to cash was also beneficial given losses in equities. Capital expenditure budgets have been approximately 20-30% lower for 2015, on average. This decline will, in our view, equate to eventual production declines. However, it may take some time before we see a stabilization or decline in production growth. We continue to strengthen the fund's exposure to holdings that we believe are well positioned for any market recovery.


