

Quarterly fund commentary

The first three months of 2018 were characterised by rising government bond yields. The main driver for the rise was stronger than expected economic data, which in turn increased expectations about the speed at which central banks would need to raise interest rates. The US Federal Reserve (Fed) increased US interest rates for the sixth time this investment cycle in March taking the upper bound of the rate to 1.75%. The latest forecasts from the Fed are for three further hikes this year. In the UK, the Bank of England signalled that it might raise UK interest rates again soon. The market currently expects a 25basis point hike in May 2018. The fund is mainly invested in government bonds (both developed and emerging markets). Although our long-term view is that government bonds. Currency markets provide another source of potential return. Current exposure includes the South African rand, Norwegian Krone and Mexican Peso. We maintain a structurally low level of interest rate rate risk (duration). However, from time to time we might add some interest rate exposure to exploit short-term investment opportunities.
