Summary of fund objective

The Fund aims to achieve a positive total return over a market cycle with a low to moderate correlation to traditional market indices, while seeking to limit the drawdown levels of the net asset value of the Fund over a rolling 12 month period. Drawdown is intended to represent the differential between the highest price achieved by the fund and lowest price observed over a 12 month period. 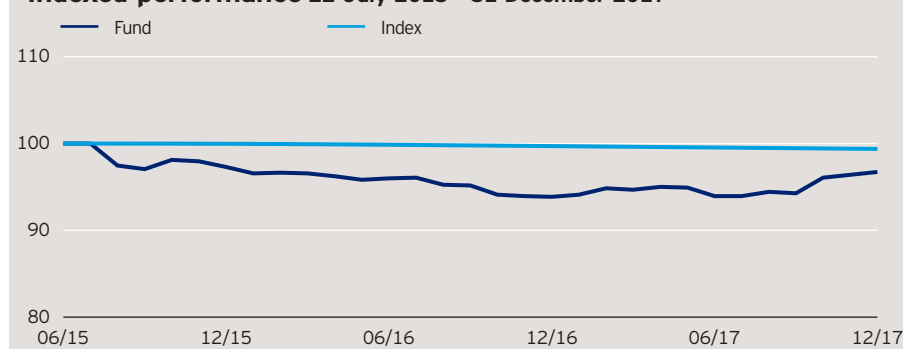

Quarterly fund commentary

Global equity markets ended the year near all-time highs amid solid corporate earnings and accelerating economic activity. Global economic growth continued to be robust and broad-based, driven by industrial activity and investment. In the US, returns were boosted by President Trump's end-of-year tax-cutting package and promised infrastructure spending. Economic growth indicators in the euro-area remained strong and picked up additional momentum over the quarter. The US Federal Reserve increased interest rates, as was widely anticipated, while members of the UK's Monetary Policy Committee voted unanimously to maintain interest rates at 0.5%. At the end of the quarter the portfolio's equity weighting was around 40%, the bond market exposure was approximately 16% and commodities accounted for 23%. In the team's view, the current outlook for global equities is moderately positive. This is based on attractive valuations, positive trend and a low risk aversion. The outlook for government bonds is predominantly moderately negative, while for commodities it is positive. The strategic allocation and tactical allocation contributed positively to the fund's performance while stock selection detracted slightly from the portfolio's return.

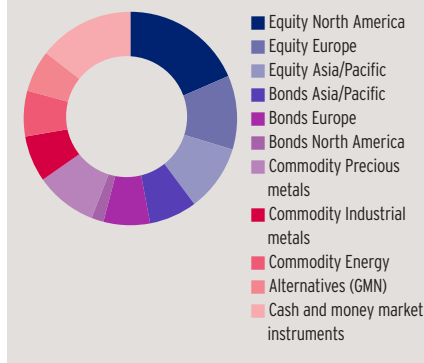
