

Quarterly fund commentary

Global equity markets ended the year near all-time highs amid solid corporate earnings and accelerating economic activity. Global economic growth continued to be robust and broadbased, driven by industrial activity and investment. In the US, returns were boosted by President Trump's end-of-year tax-cutting package and promised infrastructure spending. Economic growth indictors in the euro-area remained strong and picked up additional momentum over the quarter. The economic uptick continued to be broad-based, driven by a booming manufacturing sector as well as a robust services sector. Accelerating growth in dictors in the large victory of the ruling coalition in the snap election and ended the quarter with solid gains. The investments of the fund are determined by the outcome of multi-factor models. The fund underperformed its benchmark over the fourth quarter. Stock selection was the main detractor from return with value factors detracting most. This was only partly offset by a positive contribution from momentum-related factors.
