

Quarterly fund commentary

Government bond yields fell over the last three months of 2018. The move reflected a general deterioration in market sentiment that saw investors seek out the perceived relative safety of government bonds. The factors concerning investors included trade tensions between the US and China, Brexit, the Italian budget deficit and the pace of US interest rate hikes. During the quarter the US Federal Reserve hiked US interest rates for the ninth time in this current hiking cycle taking the upper bound of the rate to 2.50%. Despite this, US Treasuries rallied strongly with the 10-year yield falling from a 7 year high of 3.24% in November 2018 to 2.68% at 31 December 2018. The fund's largest allocation is to developed market government bonds. This exposure includes an allocation to inflation linked government bonds; predominately US Treasury Inflation Protected Securities. In addition to this developed market exposure, around 15% of the fund is currently allocated to emerging market government bonds. To benefit from the additional yield available, we also have exposure to corporate bonds. Our largest allocation within this part of the market is financials.
