

Evolution of equity exposure

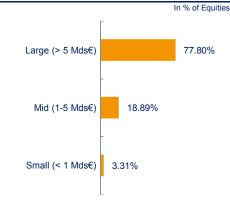
