OBJECTIVES AND INVESTMENT POLICY

The objective of the Fund is to outperform (net of fees) the Barclays Global High Yield Corporate \$ Hedged over the recommended investment period of three years [LG50TREH Index]. The Fund is primarily invested in bonds with a credit rating below “investment grade” to provide a return of capital growth and income.

The Fund invests in interest rate and money market products (corporate bonds, senior or subordinated bonds, fixed or floating rate bonds, negotiable debt instruments, certificates of deposit, etc).

Investments shall be made in accordance with the following characteristics:

- High yield (speculative) : issues rating lower than BBB- on the Standard & Poor's rating agency scale (or be considered equivalent by the Investment Manager using similar credit criteria at the time of purchase). When the issue is not rated, the rating criteria shall be fulfilled by the issuer
- Non-rated securities
- Issued by public or private sector bodies (corporate, government, government agencies, supranational institutions)
- Denominated in various currencies
- OECD issuers (including emerging OECD countries)

Risk and Reward Profile: The SRRI (Synthetic Risk and Reward Indicator) demonstrates where the Fund ranks in terms of its potential risk and return. The higher the Fund's position on this scale, the greater possible reward, but also the greater risk of losing money.

The risk category is 4, which reflects investments in speculative (“high yield”) securities in OECD countries (including emerging countries), in the private and public sectors.

Key investor information

This document provides you with key investor information about this Fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this Fund. You are advised to read it so you can make an informed decision about whether to invest.

Investors are not exposed to exchange risk, as the management includes systematic hedging to exposure to exchange. However, a residual exchange risk may persist, resulting from imperfect currency hedging of underlying assets. The Fund can also invest up to 10% of its net assets in shares or units of UCITS and/or other UCIs. The Fund may hold ancillary liquid assets.

Within the limits set out in the prospectus, the Fund may use derivatives techniques and instruments [listed, unlisted, firm or optional, rates indexes, swaps, forwards, NDF (Non Deliverable Forward), CDS (Credit Default Swap)] to increase or decrease the impact of fluctuations in financial markets on the Fund's performance. These transactions are carried out with no more than the total value of the assets of the UCITS.

You can sell shares of the Fund on a daily basis.

All income generated by the Fund is reinvested and included in the value of its shares.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Credit risk: the Fund can invest in debt securities. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer.

Counterparty risk: the Fund enters into contracts with various counterparties. If a counterparty does not fulfil its obligations to the Fund (e.g. not paying an agreed amount or not delivering securities as agreed) the Fund can suffer a loss.

Interest rate risk: an increase in interest rates may cause the value of fixed income securities held by the Fund to decline. Bonds prices and yield have an inverse relationship, when the price of a bond falls the yield rises.

Risk linked to the impact of management techniques: risk of increased losses owing to the use of financial futures instruments such as OTC financial agreements, and/or the temporary acquisition and transfer of securities, and/or futures contracts, and/or derivative instruments. 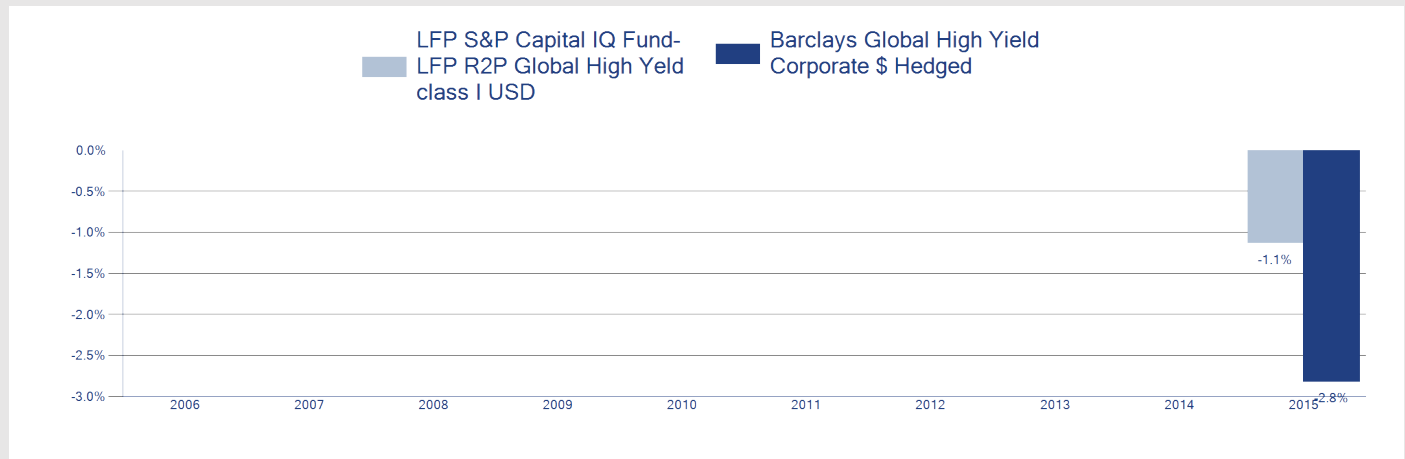
