ISIN: FR0012399731 - A sub-fund of the investment company named MULTI UNITS FRANCE (the "Company") domiciled in France.

Objectives and investment policy

L'objectif de gestion du Fonds est de répliquer, à la hausse comme à la baisse, l'évolution de l'indice EURO STOXX 50 Net return (l'« Indice de Référence »), libellé en Euros (EUR), et représentatif de 50 valeurs de premier ordre de la zone euro, tout en minimisant au maximum l'écart de suivi (« tracking error ») entre les performances du Fonds et celles de son Indice de Référence.

Le niveau anticipé de tracking error dans des conditions normales de marché est indiqué dans le prospectus.

Afin de couvrir le risque de change EUR/CHF sur la classe d'action Daily Hedged to CHF - Acc, le Fonds a recours à une stratégie de couverture quotidienne permettant de réduire l'impact de l'évolution entre la devise de l'Indice de référence et la devise de la classe d'action.

The Fund seeks to achieve its objective via a direct replication, by investing primarily in the securities comprising the Benchmark Index.

To optimize the Benchmark Index replication, the Fund may use a sampling replication strategy, and may also engaged in secured securities lending. The potential use of these techniques is published on Lyxor's website: www.lyxoretf.com. Updated composition of the Fund holdings is available on www.lyxoretf.com.

In addition, the indicative net asset value is published on the Reuters and Bloomberg pages of the Fund, and might also be mentioned on the websites of the stock exchanges where the Fund is listed.

The Fund is eligible to the French Equity Saving Scheme (PEA), and as consequence, a minimum of 75% of the Fund assets are invested in diversified equities issued in the European Union.

The share currency is the Swiss Franc (CHF).

- **Invested financial instruments:** actions internationales, parts et/ou actions d'OPCVM, autres instruments financiers.
- **Recommended Investment Period:** the Fund may not be appropriate for investors who plan to withdraw their money within less than 5 years.
- **Classification:** Equities from Euro zone countries.
- **Dividend policy:** all the Fund's amounts available for distribution (if any) shall not be distributed to Unitholders, but reinvested.
- **Net Asset Value:** is daily calculated providing that the relevant stock exchanges are open for trading and orders can be covered.
- **Redemptions:** investors are able to redeem their shares on the primary market every valuation day before 17:00 CET and sell their shares on the secondary market at any time during trading hours on the Fund listing places.

Risk and reward profile



The risk-return category shown above is based on the historical performance of the assets included in the Fund or the performance of its benchmark index or the computed performance of a portfolio model. This risk estimate may therefore not represent a reliable indicator of future risk, and may be subject to change over time. The lowest category does not mean risk free investment.

Resulting from its exposure to the Benchmark Index, the Fund has been classified within category 6. Category 6 indicates that it is possible to suffer a severe loss of capital under normal market conditions ; the value of your investment may change substantially and have quite large daily upside or downside variation.

Main risks not covered by the above indicator which could lead to a decrease in the net asset value of the Fund and which the Fund is authorized to disclose in this document (for more details about risks, please refer to the Risk Profile section of the prospectus):

- **Counterparty risk:** The Fund is exposed the risk that any counterparty with which it has concluded an agreement or a transaction could become insolvent or otherwise default and more particularly when it has concluded financial derivative instruments over-the-counter or securities lending transactions. If such an event occurs, the net asset value of the Fund may decrease significantly. According to the regulation applicable to the Fund, such risk cannot exceed 10% of the Fund's total assets per counterparty.
- **Risk of Financial derivative Instruments:** The Fund invests in financial derivative instruments. These financial derivative instruments can induce different type of risks such as (but not limited to), leverage risk, high volatility risk, valuation risk or liquidity risk. If this risk occurs, the net asset value of the Fund may decrease significantly.

Charges for this Fund

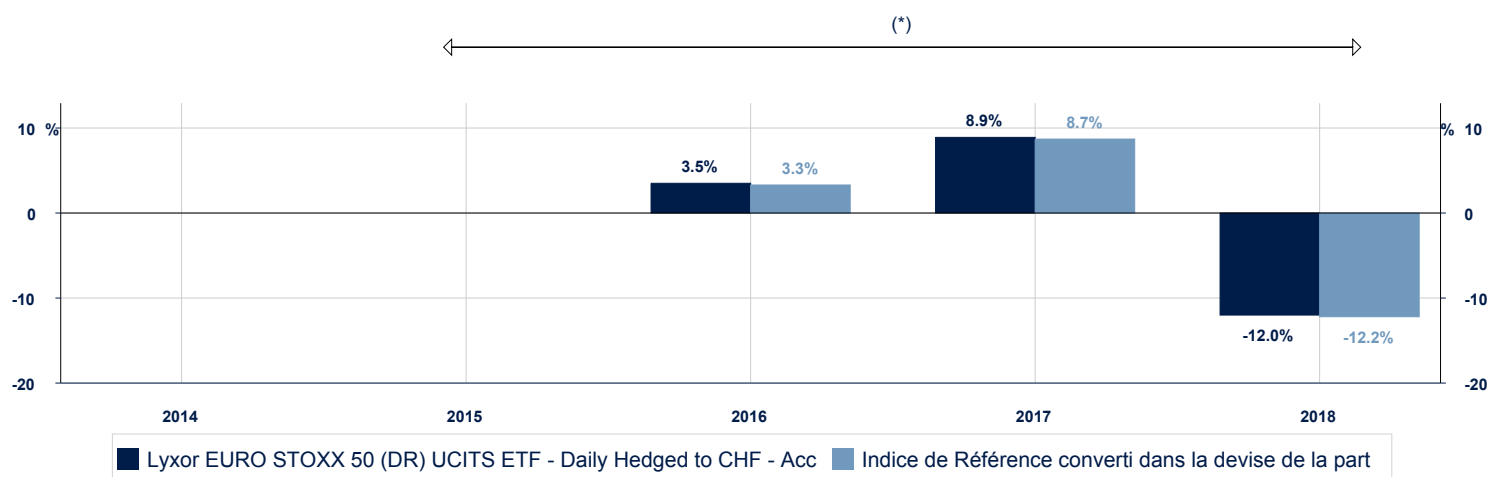
The charges you pay are used to pay the costs of running the Fund including the costs of marketing and distributing it. These charges reduce the potential growth of your investment. Entry Charge application on primary market only:	Not for the benefit of the Fund: at most, the highest between (i) 50 000 Euros per subscription request and (ii) 5 % of the net asset value per share multiplied by the number of shares subscribed. For the benefit of the Fund: au maximum 0.50 % of the net asset value per share multiplied by the number of shares subscribed.
Exit Charge application on primary market only:	Not for the benefit of the Fund: at most, the highest between (i) 50 000 Euros per redemption request and (ii) 5 % of the net asset value per share multiplied by the number of shares redeemed. For the benefit of the Fund: au maximum 0.04 % of the net asset value per share multiplied by the number of shares redeemed.
This is the maximum that might be taken out of your money before it is invested and before the proceeds of your investment are paid out. Investors can find out the actual entry charges and exit charges from their financial advisor or distributor. When investing on a stock exchange where the Fund is listed, no entry / exit charge do apply but other fees such as brokerage fees may apply.
