## FUND INFORMATION

#### Description

### **Exchange Traded Funds (ETFs)**

A UCITS ETF is a UCITS at least one unit or share class of which is traded throughout the day on at least one regulated market or Multilateral Trading Facility with at least one market maker which takes action to ensure that the stock exchange value of its units or shares does not significantly vary from its net asset value and where applicable its Indicative Net Asset Value.

#### **Investment Objective**

Lyxor Exchange Traded Funds ('ETEs') are UCITS compliant funds which track a benchmark index by investing in listed equities and entering into total or price return swaps to achieve the index performance. Swap enhanced ETFs are the most efficient way of index tracking resulting in lower tracking error while the swap counterparty bears the risk and cost of tracking the index.

The investment objective is to track both upward and downward evolution of the EURO STOXX 50 Dividend Point Futures Index (Bloomberg Code: SX5EDFT) (the "Benchmark Index"), representative of a strategy consisting of being exposed to the gross return of the EURO STOXX Dividend Points (DVP) futures contra listed on Eurex on 5 different maturities.


