This document provides you with key investor information about this fund. It is not marketing material. Objectives and Investment Policy

Alger SICAV-Alger Small Cap Focus Fund (the Fund) seeks long term capital appreciation.

The Fund generally invests at least two-third of its net assets in equity securities of companies that, at the time of purchase of the securities, have total market capitalization between:

(1) The higher of:

(a) US\$5 billion; or (b) the company with the highest capitalization in the Russell 2000 Growth Index, at any time during the most recent 12-month period as reported by such index; or (c) the company with the highest capitalization in the MSCI USA Small Cap Index, at any time during the most recent 12-month period as reported by such index; (each of the Russell 2000 Growth Index and the MSCI USA Small Cap Index, an "Index" and together, the "Indexes"); and

(2) The lower of:

(a) the company in the Russell 2000 Growth Index with the lowest capitalization, at any time during the most recent 12-month period as reported by such Index; or (b) the company in the MSCI USA Small Cap Index with the lowest capitalization, at any time during the most recent 12-month period as reported by such Index.

The Fund invests also in technology companies focused in the fields of medicine and information.

The Sub-Fund intends to invest a substantial portion of its assets in a small number of issuers, and may concentrate its holdings in fewer business sectors or industries. The Sub-Fund will hold approximately 50 securities. The number of securities held by the Sub-Fund may occasionally exceed this range for a variety of reasons.

Shareholders may redeem shares by sending a written redemption request to the Registrar and Transfer Agent. Redemption requests must be received by the Registrar and Transfer Agent in good order by 5:00 p.m. (Luxembourg time) on the Business Day preceding the Valuation Date on which the shares are to be redeemed. The right of redemption may be suspended under certain extraordinary circumstances. It is the present intention of the Board of Directors not to recommend the payment of any cash dividends out of net results. Normally, all the net investment income and all net realized and unrealized capital gains will be accumulated and shall increase the Net Asset Value per Share. Please refer to the "Dividends and Distributions" section in the Prospectus for further information.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within less than five years.



Alger Small Cap Focus Fund Class A EUH has been classified in category 6 because the fluctuation of its Net Asset Value is relatively high. The opportunity to achieve large gains corresponds to a risk of incurring large losses.

Risks related to investments in companies of small capitalizations: Stocks of small capitalization companies may be at greater risk than those of larger, more established companies owing to such factors as inexperienced management and limited financial resources. Full development of these companies takes time and, for this reason, an investment in this Sub-Fund should be considered long term and not as a vehicle for seeking short term profits, nor should an investment in this Sub-Fund be complete investment program. Many small companies' stocks trade less frequently and in smaller volume and may be subject to more abrupt or erratic price movements than stocks of larger companies. The securities of small companies may also be more sensitive to market changes than the securities of large companies.

Risks related to investments in growth stocks: Prices of growth stocks tend to be higher in relation to their companies' earnings. Growth stocks may be more sensitive to market, economic and political developments than other stocks, which makes their prices more volatile.
