

## KEY INVESTOR INFORMATION

This document provides you with key investor information about this fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this fund. You are advised to read it so you can make an informed decision about whether to invest.

### Lyxor BTP Daily Short UCITS ETF - C-EUR (the "Fund")

ISIN: LU1523098561 - A sub-fund of the investment company named Lyxor Index Fund (the "Company") domiciled in Luxembourg. Managed by Lyxor International Asset Management ("LIAM")

#### Objectives and investment policy

The investment objective of the Fund is to reflect the performance of the "SGI Daily Short BTP Index" (the "Benchmark Index") denominated in Euro (EUR) in order to offer an inverse exposure with daily 1x leverage to the performance of the Italian long-term sovereign bonds having a maturity between 8.5 and 11 years and for which Long-Term Euros-BTP Futures is a representative indicator – while minimizing the volatility of the difference between the return of the Sub-Fund and the return of the Benchmark Index (the "Tracking Error").

Over one business day, investors will be exposed to the inverse of the evolution of the level of the Parent Index, and an increase of the level of the Parent Index will result in a decrease in the Net Asset Value of the Fund that day. On the contrary, for investment periods greater than one business day, the performance of the fund will not be the inverse of the performance of the Parent Index, and could even be in the same direction.

The anticipated level of the tracking error under normal market conditions is expected to be 0.02%.

The Fund seeks to achieve its objective via indirect replication by entering into an over-the-counter swap contract (financial derivative instrument, the "FDI").

The Fund may also invest in a diversified portfolio of international debt securities, whose performance will be exchanged against the performance of the benchmark Index via the FDI. Updated composition of the Fund holdings is available on [www.lyxoretf.com](http://www.lyxoretf.com).

In addition, the indicative net asset value is published on the Reuters and Bloomberg pages of the Fund, and might also be mentioned on the websites of the stock exchanges where the Fund is listed.

The share currency is the Euro (EUR).

- **Invested financial instruments:** Derivatives, International Bonds, UCITS
- **Dividend policy:** the Fund's amounts available for distribution (if any) shall not be distributed to Shareholders, but reinvested.
- **Net Asset Value:** is daily calculated providing that the relevant stock exchanges are open for trading and orders can be covered.
- **Redemptions:** investors are able to redeem their shares on the primary market every valuation day before 17:00 Europe/Luxembourg and sell their shares on the secondary market at any time during trading hours on the Fund listing places.

#### Risk and reward profile



The risk-return category shown above is based on the historical performance of the assets included in the fund, or of its benchmark index. This risk estimate may therefore not represent a reliable indicator of future risk, and may be subject to change over time. The lowest category does not mean risk free investment.

Resulting from its exposure to the Benchmark Index, the Fund has been classified within category 7. Category 7 indicates that under normal market conditions, it is possible to suffer a sudden, severe and even complete capital loss : the value of your investment may change substantially and have large daily upside or downside variation.

Main risks not covered by the above indicator which could lead to a decrease in the net asset value of the Fund and which the Fund is authorized to disclose in this document (for more details about risks, please refer to the Risk Profile section of the prospectus):

- **Counterparty risk:** the Fund is exposed to the risk of bankruptcy, or any other type of default of the counterparty related to any trading transaction entered into by the Fund.
- **Risk of using FDI:** in order to reach its investment objective, the Fund enters into over-the-counter FDI which provide the performance of the Benchmark Index. The FDI could be affected by various risks such as change in law or tax events.
- **Issuer credit risk:** the Fund could be affected by the change in an issuer credit quality which would modify the risk of issuer default and affect the bond's value.
- **Fund Liquidity Risk:** the Fund's liquidity and/or value may be affected if, when rebalancing its exposure it is unable to execute trades in line with the index.

## Charges for this Fund

The charges you pay are used to pay the costs of running the Fund including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

One-off charges taken before or after you invest	
<b>Entry Charge application on primary market only:</b>	At most, the highest between (i) <b>50 000</b> Euros per subscription request and (ii) <b>5 %</b> of the net asset value per share multiplied by the number of shares subscribed.
<b>Exit Charge application on primary market only:</b>	At most, the highest between (i) <b>50 000</b> Euros per redemption request and (ii) <b>5 %</b> of the net asset value per share multiplied by the number of shares redeemed.
This is the maximum that might be taken out of your money before it is invested and before the proceeds of your investment are paid out. Investors can find out the actual entry charges and exit charges from their financial advisor or distributor. <b>When investing on a stock exchange where the Fund is listed, no entry / exit charge do apply but other fees such as brokerage fees may apply.</b>
