OBJECTIVES AND INVESTMENT POLICY

The objective of the Fund is to outperform (net of fees) the Barclays Global High Yield Corporate Total Return Index Hedged EUR, over any given 3-year period. The Fund invests mainly in below investment grade (high yield) bonds in any currency from issuers in OECD countries, including those considered emerging markets.

Specifically, the Fund invests in fixed and floating rate negotiable debt instruments, certificates of deposit and money market instruments issued by public and private issuers. The Fund invests in issues that are rated lower than BBB or judged equivalent by the investment manager at the time of purchase.

The Fund may invest in, or be exposed to, the following investments up to the percentage of net assets indicated:

- unrated securities: 20%
- contingent convertible bonds (coco bonds): 10%
- other UCITS/UCIs: 10%

RISK AND REWARD PROFILE



Risk and Reward Profile: The SRRRI (Synthetic Risk and Reward Indicator) demonstrates where the Fund ranks in terms of its potential risk and return. The higher the Fund's position on this scale, the greater possible reward, but also the greater risk of losing money.

You can buy and sell shares of the Fund daily.

Interest rate risk: an increase in interest rates may cause the value of fixed income securities held by the Fund to decline. Bonds prices and yield have an inverse relationship, when the price of a bond falls the yield rises.

Emerging markets risk: emerging markets are more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

Derivative risk: the Fund uses derivatives. These are financial instruments whose values depend on the value of the underlying asset. Small price fluctuations in the underlying asset can result in large price changes in the derivative.

Contingent Convertible (“Coco”) Bond Risk: investment in this particular type of bond may result in material losses to the Fund based on certain trigger events. The existence of these trigger events creates a different type of risk from traditional bonds and may more likely result in a partial or total loss of value or alternatively they may be converted into shares of the issuing company which may also have suffered a loss in value. Such trigger events may include a reduction in the issuers' capital ratio, determination by a regulator or the injection of capital by a national authority. Investors should be aware that in the event of a financial crisis that action by regulators or the companies themselves may cause concentrations of these trigger events across the Fund.
